**NOTIFICATION**

**Dated 19<sup>th</sup> August, 2022**

**No. BMJ/L&O/70/20-19/8-9:** Whereas, the Government of Assam through the "State Level Recruitment Commission for Class-III Posts" and "State Level Recruitment Commission for Class-IV Posts" is going to conduct written examinations for recruitment to the vacant posts of class -III and Class-IV in different State Government establishments for the eligible candidates;

Whereas, secondary education Board of Assam (SEBA) on behalf of the "State Level Recruitment Commission for Class-III Posts" and "State Level Recruitment Commission for Class-IV Posts" has announced the schedule of holding of such written examinations in different examination centers covering 25 districts of Assam on 21/08/2022, 28/08/2022 and 11/09/2022;

Whereas, the venues for the examination in the district are decided to be at (a) Bongaigaon College, (b) Bongaigaon HS School(EM), (c) Hindi HSS, (d) Bongaigaon Rly HSS (e) Birjhora Girls HS, (f) Birjhora Kanya Mahavidyalaya, (g) Birjhora HSS, (h) Sankardev Sishu Vidya Niketan, Bakharapara, (i) St. Albert School, (j) North Bongaigaon HS;

Whereas, the total number of candidates appearing in the written examinations in all papers in the district will be **9948nos.**

Whereas, in order to hold the examination in free, fair and transparent manner and to restrict the involvement of any undesired external influence, no malpractices should be allowed during the entire examination process, which might vitiate the peaceful environment in and around the examination venues;

Whereas, there is every possibility of unscrupulous elements resorting to unfair means to disturb the free, fair and transparent examination process in and around the examination centers which is likely to create obstruction, annoyance or injury to any person lawfully employed, or danger to human life, health or safety, or a disturbance of the public tranquility, or a riot, of an affray;

Whereas, it is considered to be prudent and expedient, in the interest of holding free, fair and transparent recruitment examination during examination hours on the days fixed for holding such written examination which might disturb the examination process which is likely to create obstruction, annoyance or injury to any person lawfully employed, or danger to human life, health or safety, or a disturbance of the public tranquility, or a riot, of an affray, to put reasonable restrictions on following activities;

Therefore, I, Sri Nabadeep Pathak, ACS, District Magistrate, Bongaigaon hereby promulgate this Notification under Section 144 Cr.PC prohibiting the following activities on 21/08/2022, 28/08/2022 and 11/09/2022:

- a) Gathering of people within the radius of 100 meters of each examination centers other than candidates, scribes and officials engaged for conduct & monitoring of examination.
- b) Carrying of prohibited items in the examination halls by the candidates such as,
  - i. Mobile Phones (even in switch off mode)
  - ii. Any electronic equipment's or programmable device or storage media devices such as smart watches, health bands, electronic pen/scanner, Bluetooth devices, earphones, microphones or any other such devices either in working or switched off mode capable of being used as a communication device.
  - iii. Calculator, pen drives, bits of paper etc.
  - iv. Textual material (printed or written) and
  - v. Any item which could be used for adopting unfair means

Violation of this promulgation will be punishable under relevant provisions of law.
