No.BMJ/50/2018/84: In continuation of this office order No.BMJ/50/2018/83 dated 02/02/2023 the para No.5 may be read as follows:

5. Notary/Kazi should not indulge in practice of making unlawful affidavits for supporting child marriage and agreements between underage people for marriage for present or future. Necessary action under Section 10 and 11 of Prohibition of Child Marriage Act, 2006 will be taken for cancellation of license on case-wise basis and disciplinary proceedings as mentioned in law shall be initiated. For advocates, Bar Council will be approached for such type of misconduct if any.

This order shall come into force with immediate effect.
