# MINUTES OF THE DDC MEETING HELD ON 04th AUGUST/2022 AT 11.00 AM IN THE CONFERENCE HALL OF D.C. OFFICE, BONGAIGAON.

The meeting was presided over by Sri Bhaskar Das, ACS, District Development Commissioner, Bongaigaon.

At the outset, the Chairman welcomed all the members present in the meeting. The District Development Commissioner reviewed the progress work of two important programme i.e. Chief Minister's Institutional Plantation Programme and HarGhar Tiranga.

# Chief Minister's Institutional Plantation Programme(CMIPP):

- > The Chairman urged all the HODs to upload Geo-tagged Plantation photo to the portal www.shyamaleechouhad.assam.gov.in.
- > The Chairman instructed
  - i) Shlipi Rekha Pandit, ACS, Assistant Commissioner to visit the Sericulture premise and other places where plantation done by Sericulture.
  - ii) Assistant Director of Sericulture to use Superintendent office for Plantation.
  - iii) Shyamashree Saikia, ACS, Assistant Commissioner to visit Agnnawadi Centre.
- Regarding Har Ghar Tiranga programme All HODs > Har Ghar Tiranga: informed to the Chairman that briefing has been done to employees including those engaged in contractual basis along with all stake holders to hoist the National Flag from 13th to 15th August, 2022.

Thereafter, the house reviewed the progress of work done by all the deptts and following decisions have been adopted.

### 1. Fisheries:

> Construction of biofloc has already been completed but yet to be operational. The DFDO was directed to operationalize the biofloc by 20 August, 2022.

- > On a query from Chair the GM, DICC informed that anyone whose CIBIL score is good may get loan from PMEGP. 372 nos of loans are under process. In this regard, the GM, DICC was directed to issue an instruction for completion of the remaining process.
- > GM, DICC informed that 74 Nos. application of Artisans Card collected from the Bamboo Mat artisans and after verification 8 Nos. of Artisans Card already distributed to the beneficiaries.
- > Efforts are on for formation of 2 (Two) Co-operative Societies of the Bamboo Mat artisans for enabling them for Incentives under Mukhya Mantrir Tholuwa Udyog Bikash Achani (MMTUBA).
- > GM, DICC was directed to include such artisan category in PMJVK scheme.

> On quary of DDC regarding land requirement for Solar project, The ADC North Salmara informed that no Government land available in Srinjangram and Boitamari. The Chairman directed ADC to look into the matter and urge to inform feasibile of Floating Solar project if any.

➤ On a query from Chair , the AGM,APDCL informed that electric connection on 945 AWCs out of 1000 have already been completed and rest 55 nos will be completed by 04/09/2022.
