

Part.V. Recommendation of the M&E Observer:

Self visited the site of work viz. "Construction of common workshed at Jelkajhar Part I(Phase-1)" under MGNREGA, 2020-21 along with Shri Ranjan Sanyashi, RA, DC's office Bongaigaon and Shri Gautam Chandra Roy, Act. Engineer, Dangtol Development Block, Bongaigaon and President, Mulagaon Gaon Panchayat on 29/12/2022.

It has been observed that two nos, of workshed alongwith infrastructure for production of Biofertilizer such as NADEP Composed Pit, Vermicomposed Pit, Pucca Storage for agriculture production, Group nursery and fish breeding pond was found constructed. The works were taken up under the scheme SWANIRBHAR Nari ATMANIRBHAR Axom in convergence with MGNREGA, 2020-21. The signboard found at the site of work is in English. Though the work is completed it is yet to be handed over to the Self Help Group for it's maintenance.

However, the President, Mulagaon Gaon Panchayat assured that the handing over of the assets to the SHG will be done in a short period.
