PROHIBITORY ORDER

Whereas it has been reported by the Indian Meteorological Department, Ministry of Earth Sciences, Govt. of India regarding Heavy (7-11 cm in 24 Hrs) to Very Heavy rain (12-20 cm in 24 hrs) along with isolated Extremely Heavy rain (21 cm or more) in Bongaigaon district; and

Whereas, due to extremely heavy rain, there may be a sudden rise in water levels of rivers, resulting in the overflow of major rivers, which may cause boats capsized and potentially lead to human casualties; and

Whereas, I am satisfied that there is an emergent need of imposing restriction to curtail the movement/plying of Machine/Country Boats along the Aie, Manas and Brahmaputra River within the jurisdiction of Bongaigaon district for safety and security of commuters and to prevent loss of precious lives.

In view of the urgency of situation I, Sri Nabadeep Pathak, ACS, District Commissioner & Chairman, DDMA, Bongaigaon in exercise of power conferred upon me under **section 34(b)** of DM Act-2005 do hereby prohibit the movement/plying of Boats both **Machine and Country Boats** along the river Brahmaputra, Aie and Manas under the jurisdiction Bongaigaon district w.e.f. **19/06/2024 to 03/07/2024 for 15 days.**

This order will be reviewed after 15 days.
