3. The bidders should have experience of previous auction.


4. Materials will be collected in "as is where is" basis.

8. The successful bidder must deposit the full amount within 3 days from the date of acceptance of bid. In proper head (0070-OAS) in state exchequer (Bongaigaon Treasury via. Treasury Challan) and submit the same to this office for office record.
9. After making full Auction amount, the bidder/vendors will be allowed to lift the materials, dispose all the materials and clean the site on his own arrangement within 10 days from the date of issue this order.
10. No complaint regarding quantity or quality will be entertained after finalization of auction.
