4. Disseminate verified updates, warnings, advisories, and emergency information.
5. Counter fake news through prompt factual communication.
6. Manage official social media handles of District Administration.


All concerned officers/officials shall remain on alert during disaster situations and maintain close coordination with the District Emergency Operation Centre (DEOC)/Control Room for timely dissemination and verification of information. The District Control Room No. 7086793507 shall remain operational round the clock for receipt of information and necessary coordination during emergencies.
