

**MINUTES OF THE DDC MEETING HELD ON 24th Feb/2022 AT 11.00 AM IN THE
CONFERENCE HALL OF D.C. OFFICE, BONGAIGAON.**

The meeting was presided over by Sri Bhaskar Das, ACS, District Development Commissioner , Bongaigaon.

At the outset, the District Development Commissioner, Bongaigaon welcomed all the members present in the meeting.

The meeting reviewed the minutes of last DDC meeting and progress of work of various deptt. After threadbare discussion following decisions/resolution were adopted.

1. Co-operation:

- As decided in the last DDC meeting, the ARCS, Abhayapuri informed that no officials of ARCS have been entrusted in Paddy Procurement Programme. The ARCS was directed to submit list of officials to District Agriculture Officer so he can take necessary steps for entrusting them in Paddy Procurement Programme.

2. Social Forest:

- As resolved in the last meeting , the DFO,Social Forest informed that estimate has been prepared for "Miyawaki" forest (a form of forestation) in Bongaigaon district. Specially medicinal plants are to be planted under "Miyawaki" forest. The District Development Commissioner directed the DFO to submit the estimate to Deputy Commissioner for taking necessary steps

3. Soil Conservation:

- On a query from the Chair, the D. O, Soil Conservation informed that as resolved in the last meeting , survey report with list of all the vulnerable location where projects can be taken up under Soil Conservation has been submitted to the Deputy Commissioner. He also informed that e-tendering of four new schemes is under process.

4. Handloom & Textile:

- Supdt. H & T, Abhayapuri informed that a new scheme "Swanirbhar Nari" is launched by the Gov. Under the programme indigenous Gamosa will be procured from registered weavers having yarn pass book . The Chairman once again directed the Supdt of H & T to complete the survey of weavers in the district by March/2022 and submit list of weavers without fail.
- Regarding Mudra Loan, the Supdt. H & T, Abhayapuri informed that 94 nos of loan proposals under MUDRA Loan submitted to bank branches and survey by banks is going on. Once again the Supdt. H & T, Abhayapuri was directed to peruse bank concerned regarding sanction of loan. Also directed to submit list of lonee to Deputy Commissioner.

5. Sericulture:

- Assist Director, Sericulture informed that som plantation on 1 acr land has been done at Nayagaon VGR.
- As resolved in the last DDC meeting, Assistt Director, Sericulture informed that proposal for maintenance of Som plantation has been submitted to CEO,ZP, Bongaigaon for approval under MGNREGA.

- Regarding Establishment of Eri Concentration Centre (ECC) at Barbhakra, under Manikpur Development Block, under "Silk Samagra Mission", the Assist Director, Sericulture informed that proposal has been sent to The Hon'ble Minister, Sericulture through the Director sericulture.
- Assist Director, Sericulture informed that Training on Cocoon NABARD Finance completed. Out of 30 trainee 3 Joint Liability Group has been formed and approached to bank for opening account.

6. Veterinary:

- The DVO, Bongaigaon informed that Construction of V.O quarter, water supply and state Vety. Disp. at Chalantapara under SOPD has already been completed.
- As reported by the DVO vaccination and Ear Tagging is going on. Progress of Ear Tagging is 42.40%.
- Under NLM (SCSP) 100 nos beneficiaries have been selected for distribution of Rural backyard Goat.
- Regarding renovation of hatchery near Srijangram Block Vety Dispensary, the DVO informed plan & estimate is prepared and submitted to the Hon'ble MLA, Abhayapuri(North) LAC for fund.

7. Industry:

- GM, DICC informed that 301 nos applications under PMEGP have been sponsored to bank out of which only 40 nos have sanctioned by bank branches. GM DICC was directed to follow up the matter with bank.
- GM, DICC informed that An amount of Rs68.00 lakhs has been sanctioned under NEIPE.
- It is informed that in Bongaigaon district "Maize" is selected as ODOP.
- GM, DICC requested all the HODs to convey the message regarding registration of entrepreneurs under UDYAM. The Chairman directed the GM, DICC to share list of schemes under PMEGP to all HODs.

8. Agriculture:

- Regarding Paddy Procurement, the District Agriculture Officer, Bongaigaon informed that total 540 MT paddy procured in the district. Also informed that PPC at Dangtol and Salabila yet to be started.
- Under PMFBY, 12435.155 area insured with 22877 farmers and achieved the target. DAO informed that an amount of Rs 8.00 cr has been received for loss compensation of Kharif crops.
- 1363 nos KCC achieved out of targeted 6000 nos.
- DAO informed that under CMGUSY 472 nos villages out of 563 have been completed and 472 nos tractor have been distributed in two phases. Now the scheme has been closed.

9. Agri. Engineering:

- The AEE (Agril) informed that Distribution of STW with solar PV Pump set and diesel pump set under RIDF (1st phase) has been completed. Under RIDF (2nd phase) DD for 72 nos Solar diesel pump set is ready for deposit as share money. 4 nos of FPC selected for establishment of Village level Farm Machinery Bank (VLFMB) @95% Govt subsidy of Max Rs.10.00 Lakhs. under Sub- Mission on Agricultural Mechanization (SMAM). DD received from 4 nos FPC against 7 nos selected FPC. Regarding establishment of Mini Rice Mill per GP, the Chairman directed the AEE to write letter to Govt for sanction.

10. Skill Development:

- On a query from Chair, the DPM, ASDM, Bongaigaon informed that there is no target for the district. only earlier 4 nos training centre are active in the district.
- The Mahatma Gandhi National Fellow suggested to hold District Skill Committee meeting regularly. The DDC directed the DPM to take necessary action in this regard.

11. Legal Metrology:

- ACLM, Bongaigaon informed that out of Rs. 11.00 lakh annual target of revenue collection Rs 8.00 lakh only achieved till today. DDC directed the ACLM to achieve the target in schedule time.
- On a query from Chair the ACLM informed that compounding will be started by tomorrow.

12. Food & Civil Supply :

- On a query from chair regarding One Nation One Ration Card(ONORC) , the Dy Director of FCS&CA informed that due to technical problem progress of Adhar seeding is slow. However, progress of Adhar seeding is 77.06% (Ration card: 52.60%) .
- Progress of Paddy Procurement is slow.
- As resolved in the last DDC meeting, the Supdt. Of Supply informed that Joint inspection has already been started for No Helmet No petrol.

13. Education:

- The Inspector of Schools informed that received fund under RMSA against 6 nos of school have already been utilized . 2nd installment fund yet to receive.
- Regarding online attendance of teachers through 'RIMS' , the Inspector of schools informed that percentage of teachers attendance is 46%. Also apprise the house that teachers of elementary education are reluctant to put attendance through RIMS.

14. Revenue:

- While reviewing the land revenue collection in Bongaigaon district , the ADC(Rev) , Bongaigaon informed that due to shortage of manpower collection of revenue is slow.
- Regarding Basundhara project, the Chairman directed all the Circle Officers to achieve the target as per schedule date.

15. Sports:

- Regarding Playfield Development work under Assam Youth Development Mission Society of MMS-CMSGUY, the DSO informed that , work against 10 nos school are going on and 2nd installment fund received against 4 schools. The Chair directed the DSO to complete the work by Mar/2022.
- The DSO also informed that an amount of Rs 12.00 Cr has been sanctioned for Mini Stadium at Barshangaon and for this land verification is to be needed. The Chairman directed him to contact concerned Circle Officer.

16. APDCL:

- On a query from Chair, the AGM, Bongaigaon informed that electrification of AWC and Primary schools will be completed by Mar/2022

17. PWD(bldg):

- As informed by the AEE, PWD(Bldg), Abhayapuri informed that Construction of Model school at Piradhara, Tapattary Block will be completed by 15th Mar/2022.
- Progress of Construction of Mini Stadium and Tennis Play ground at Abhayapuri is slow due to non-receipt of fund from govt.
- Piling work of Development of Stadium at North Bongaigaon under CIDF is going on.
- Progress of Construction of New Engineering College at Bongaigaon is only 17%. Also informed that blasting permission is yet to issue for which progress delayed.

18. PWD(Electrical Divn):


- As informed by the EE, PWD, Electric Divn, Kokrajhar, work at Bongaigaon has been stopped due to examination.
- External work of Bongaigaon B.Ed College is 30% completed till date.

19. Social Welfare:

- **SNP:** While reviewing the progress of SNP, the i/c DSWO informed that fund for 27 days has been released and fund for another 52 days has been received from govt. The Chairman expressed his dissatisfaction on the slow progress of SNP and directed the i/c DSWO to communicate with the CDPOs and Supervisors for gear up the progress so that target can be achieved in time.
- **PMMVY:** Regarding PMMVY, the i/c DSWO informed that target has been received. Yearly Target based on estimated population for the year 2021-22 is 3685 and Achievement is 4239. Percentage of achievement is 115%.
- Regarding SAM & MAM screening report as on Feb/2022, it is found that there is some incorrect data has been reported. i/c DSWO was directed to look into the matter and correct it.
- Regarding One Stop Centre, i/c DSWO informed that no fund is received by the NGO(Sarbangee) for maintaining the centre. The Chairman directed him to take up the matter with higher authority.


